3. Tenant shall surrender and return the premises to the Landlord prior to the Lease Termination Date in as good a state and condition as they were at the beginning of the Lease Agreement.

Upon satisfaction of the obligations set forth in this Agreement, neither the Landlord nor the Tenant shall have further rights or obligations with respect to the Lease Agreement. If any legal action is commenced to enforce or interpret the terms of this Lease Termination Agreement, the prevailing party shall be entitled to reasonable attorney's fees and costs in addition to any other relief to which the prevailing party may be entitled.

This Agreement shall be governed, construed and interpreted by state law. This Agreement shall constitute the final agreement and understanding of the parties on the subject matter hereof. If any provision of this Lease Termination Agreement is deemed invalid or unenforceable, the remaining provisions of this Agreement shall be enforced to the maximum extent permitted by law.
